Introduction

Not FDA Approved



According to the FDA Fact Sheet¹

There is no U.S. Food and Drug Administration (FDA) approved vaccine to prevent COVID-19.

The Pfizer-BioNTech COVID-19 Vaccine is an unapproved vaccine that may prevent COVID-19.

The Pfizer-BioNTech COVID-19 Vaccine has not undergone the same type of review as an FDA-approved or cleared product.



Fast tracking a vaccine takes a minimum of 5 years. The Pfizer COVID-19 experimental vaccine, not FDA approved, was authorized after just a few months.



NO animal testing was done, and in the human study, "Phase 3" was completely omitted. Only young, healthy people were studied. **NO** children, elderly, or pregnant women were in the study. **NO** long-term effects have been measured.



HOW EFFECTIVE IS IT?

The Vaccine Is Not As Effective As Your Immune System

The IFR (Infection Fatality Rate) of COVID-19 for people under 69 years old is **less than 1%.**

For children and adolescents, it is **0.003%**

Across all ages, the human immune system, on average has a **98%** effectiveness rate against the virus.

The Moderna COVID-19 vaccine is currently posting a 94.1 percent efficacy rate² and the Pfizer and BioNTech vaccine are showing a 95% efficacy rate.³

But Wait, There's More!

The FDA has allowed "effectiveness" to be defined as "prevention of mild symptoms."

America's Frontline Doctors



The vaccine is an experimental biological agent.

According to the FDA, "An investigational drug can also be called an experimental drug and is being studied to see if your disease or medical condition improves while taking it." America's Frontline Doctors (AFLD) has researched that Pfizer, Moderna, and AstraZeneca applications properly identify their vaccines as "investigational."

There is no proof the experimental vaccine stops transmission.

You are enrolling in a clinical trial.

If you take a vaccine, you're being enrolled in a medical trial and a pharmaco-vigilance surveillance system (contracted by the U.S. Department of Defense with Google and Oracle) in which you will be tracked for 2 years.


"The decision means the vaccine will not be available for sale in the world's two most populous countries, India and China, in the near future. Both countries are running their immunisation campaigns using other products."

No Accountability

Zero Liability? Let this sink in.



The pharmaceutical companies have been given **legal immunity** from liability.⁸ They have **ZERO liability** for any longterm effects of the vaccine.

Let this sink in for a moment. What could possibly go wrong? When there is no accountability, there exists opportunity for negligence, recklessness, shortcuts, departure from integrity and compliance, among many other potential risks.

Why should I care? This lack of accountability can yield a higher risk of vaccine injuries, and even death, as we are witnessing now.

Vaccine Deaths & Injuries

Citing CDC data, LifeSiteNews⁹ reported that as of January 22, **at least 271 deaths**, and **9,845 adverse events** have occurred after COVID vaccination so far in the U.S. The data indicates that the deaths, reported by the vaccine injury tracking system (VAERS)¹⁰ for the CDC, mostly occurred **within 48 hours** of the vaccine being administered.

A study shows only about 1% of actual cases are picked up by the VAERS system."





In Europe, Investment Watch Blog (IWB) reports,¹² about **730 deaths** and **8 cases of spontaneous abortion** has been recorded by EUDRA,¹³ Europe's tracking system, following Pfizer vaccination.

(The following deaths and injuries are cited in the LifeSiteNews report.)



Vaccine Deaths & Injuries

28yr old male, no pre-existing conditions.

Pronounced dead after being put on cardiac life support after being found "unresponsive at work," two weeks after receiving the Pfizer vaccine.

88yr old female with arthritis and high blood pressure.

After experiencing pain in the back of her head and extreme headache, went into a coma and was intubated. A hole was drilled in her skull to relieve pressure. She suffered bleeding in the brain and an aneurism that led to her death 14 hrs after her initial symptoms.

An older Florida man with a "clean bill of health."

Became sick 3 hours after the vaccine and was found deceased 1 day after his vaccination.

45-year-old mother.

Died "in the middle of the night" following vaccination with the Moderna vaccine the day before.

Nearly identical cases have been reported across the U.S.

4 elderly women in nursing homes.

VAERS notes the incidents of four elderly women, most of whom had survived COVID-19, all dying in nursing homes on the same day within hours of receiving Pfizer shots from the same lot.

8 unborn babies.

Eight unborn babies, many of them late-term and otherwise healthy, also were miscarried or stillborn soon after their mothers received the Pfizer vaccine, according to VAERS. **Pfizer** has warned that "pregnancy should be excluded" before vaccination.

VAERS also reports dozens, if not hundreds, of debilitating, non-fatal reactions to the vaccine, including seizures, cardiac arrest, and hemorrhage.



Get the Vaccine, Get Your Life Back?

According to Dr. Fauci, people will still need to wear masks, practice social distancing, and avoid large crowds even after getting the vaccine.

In a CNN interview with Jake Tapper, Fauci said, "Obviously, with a 90-plus percent effective vaccine, you could feel much more confident...But I would recommend to people to not abandon all public health measures just because you have been vaccinated," because "even though, for the general population, it might be 90[%] to 95% effective, you don't necessarily know, for you, how effective it is."

CNBC reports, "it is worth noting that as the trials for both vaccines progress, efficacy numbers could change, **and it is also not yet clear how long any immunity would last**."¹⁴

What Happened To The Flu?

CDC's Website States

Seasonal influenza activity in the United States remains lower than usual for this time of year.

2017 45 Million

The CDC said the "flu killed 80,000 people this past season and put 900,000 into the hospital, making it the worst influenza season in decades "15

CDC estimates that the burden of illness during the 2017–2018 season was high with an estimated 45 million people getting sick with influenza.

2018 42.9 Million

In total, the CDC estimates that up to 42.9 million people got sick during the 2018-2019 flu season, 647,000 people were hospitalized and 61,200 died.

2019 39-56 Million

CDC estimates 39-56 Million illnesses and 24-62,000 deaths.

What happened to the flu?

According to the CDC, the "flu kills anywhere between 12,000 and 56,000 people a year, depending on how bad the flu season is, and that it puts between 250,000 and 700,000 into the hospital with serious illness."¹⁵

Normal flu rates are 9,000,000-43,000,000.
